- Cat will only be permitted on a safe and catproofed balcony.
- I will immediately inform Green Paws' team of any behavioral issue and will cooperate with them on suggested solutions to resolve the issue.

If -for any reason- I can no longer keep the cat, I have no legal rights to rehome the cat myself, but have to return the cat to Green Paws LLC, who will need a MINIMUM of 15 days' notice before moving that cat.
